



"Recently" Released Ontario Civil Registration Indexes Now Available at VPL

Each year a new annual set of Ontario civil birth, marriage and death records and related indexes is released and goes on sale. Vancouver Public Library acquires the indexes, which genealogists use to identify and place interlibrary loan requests for Archives of Ontario microfilms containing images of the original records.

Normally, there is a delay between when the records and indexes are released and when they become available for purchase. This year, they were not received at the Vancouver Public Library until shortly before the lengthy strike. Since this is the first newsletter to appear since Summer 2007, we are belatedly pleased to tell you that the following Ontario civil registration indexes are now available on Level 6 at the Central Branch:

- Births 1910
- Marriages 1925
- Deaths 1935

With New Year 2008 already underway, we look forward to ordering the next set of indexes at the earliest opportunity.

Genealogists with ancestors who arrived in Nova Scotia before Confederation may find useful information in these two volumes, which consolidate a vast amount of data on individual immigrants to Nova Scotia collected from a variety of sources.

Part 1 of the first volume is derived from 46 manuscripts, including many passenger lists. Most are housed at the Public Archives of Nova Scotia although some of the manuscripts are located in other repositories. Part 2 is based on references to individuals found in 467 articles published in Nova Scotia genealogical and historical periodicals.

Part 1 of the second volume is derived from references to Nova Scotians found in 51 articles published in non-Nova Scotia genealogical and historical publications. Part 2 is based on references found in facsimile publications of personal diaries and journals.

Legal Matters Related to Genealogy

A series of articles recently published in the Ontario Genealogical Society's *Families* journal provides an excellent introduction to legal aspects of genealogy such as privacy and personal data protection and copyright. The author, Dr. Margaret Ann Wilkinson, is a professor in the Faculty of Law and the Faculty of Information and Media Studies at the University of Western Ontario. The four articles are particularly valuable because they explore legal aspects of genealogy from a Canadian perspective. The series is entitled Legal Matters Related to Genealogy and appears in four issues of *Families* as follows:

UBC Student Yearbook Photograph Collection

From the time that U.B.C. first opened its doors in 1915-16 until 1966, the Alma Mater Society published a student yearbook. *The Annual* -- renamed *The Totem* in 1926 -- eventually suspended publication after 49 volumes.

1750 photos published during *The Totem*'s 50-year run can now be viewed online at http://angel.library.ubc.ca/cdm4/

The searchable web gallery offers a rich selection of photos chronicling the university's life and includes many photos of faculty members as well as group photographs of student executives, sporting teams, cheerleaders, fraternities and others. The names of individuals in group photos are not listed, but for anyone with family history connections to U.B.C., this site is worth a look.

News from the Canadian Genealogy Centre

Ancestors Search Now Available

One of the outstanding features of the Canadian Genealogy Centre website is its rich suite of free databases. Many can be searched by name, but until recently, each database had to be searched individually. The Canadian Genealogy Centre has now introduced a feature that allows simultaneous searching of multiple databases. Ancestors Search can be done with Exact Match turned on or off. Results are organized according to broad categories such as Immigration and Citizenship or Military. **Ancestors Search** can be accessed through the Canadian Genealogy Centre (www.genealogy.gc.ca) or directly from Library and Archives Canada's homepage (www.collectionscanada.ca/index-e.html).

<u>Irish Census Records – Free Online</u> <u>Access!</u>

On December 3, 2007, the National Archives of Ireland launched the first stage of its 1901 and 1911 Census Digitisation Project. The first stage includes digitized images of 1911 census records for Dublin City and County, together with a complete nominal index. The records can also be browsed geographically by place. The database is available for free at www.census.nationalarchives.ie/

the National Archives of Ireland and Library
and Archives Canada, considered a world
leader in the field of document digitization.

Oral Histories of the First World War: Veterans 1914-1918

A new web exhibition by Library and Archives Canada offers first-hand accounts of the experiences of the First World War from veterans of the Canadian Expeditionary Force. **Oral Histories of the First World War:** Veterans 1914-1918 is based on a CBC radio series, In Flanders Fields, which aired in the 1960s. The exhibition comprises both digitized radio recordings and transcripts. The selected accounts explore seven themes: Second Ypres, Vimy Ridge, War in the Air, The Somme, Trench Warfare, Passchendaele, and Perspectives on War. For the many Canadian genealogists whose ancestors joined up in World War I, the web exhibition offers a compelling way of gaining insight into the soldiers' experiences.

The Shamrock and the Maple Leaf

Library and Archives Canada has produced an online exhibition of Irish-Canadian documentary materials entitled **The Shamrock and the Maple Leaf**. Like the **1901 and 1911 Census Digitisation Project** (see above), **The Shamrock and the Maple Leaf** reflects an active and ongoing cultural collaboration between LAC and the National Archives of Ireland. The exhibition is a rich source of contextual information for those researching Irish-Canadian roots.

Who Do You Think You Are?

The Canadian Broadcasting Corporation (CBC) launched a new genealogy series in October 2007. Who Do You Think You Are? offered viewers a chance to watch 13 celebrities make individual journeys into family history. The Canadian celebrities profiled included Mary Walsh, General Lewis Mackenzie, Chantal Kreviazuk, Sonja Smits, Steven Page, Margot Kidder, Shaun Majumder, Randy Bachman, Scott Thompson, Don Cherry, Measha Brueggergosman, Margaret Trudeau, and Avi Lewis. Each documentary episode followed along as one celebrity worked with genealogists and archivists, sometimes travelling as far as India or Poland to explore their family roots.

The series, developed in collaboration with Library and Archives Canada, emulates a British Broadcasting Corporation series of the same name that has been wildly popular, running into several seasons and spawning three books. The Australian Broadcasting Corporation is planning a similar endeavour.

There is no word on yet future plans for CBC's Who Do You Think You Are? or when previously aired episodes might re-run or become available on DVD. Check the program's website for detailed reprises of each episode and further information.

News from Ancestry

Ancestry is a popular genealogy database available to home subscribers as Ancestry.com. A mirror site highlighting Canadian content is available as Ancestry.ca. Vancouver Public Library subscribes to a library version entitled Ancestry Library Edition.

Early Canadiana Genealogy and Local History Collection Online

Canadiana.org (formerly the Canadian Institute for Historical Microreproductions or CIHM) is a nonprofit organization committed to preserving and providing access to early Canadian publications. Canadiana.org initially established the Early Canadiana Research Collection, reproducing and distributing historical publications on microfiche.

For Canadian genealogists, a notable subset of the original Early Canadiana Research Collection is the Genealogy and Local History to 1900 collection. A printed bibliography of this collection is available at the Vancouver Public Library (Ref. 929.1X G46g).

Recently, **Ancestry.ca** and **Canadiana.org** announced a partnership to digitize the **Genealogy and Local History to 1900** collection and make it available through **Ancestry**.



Canadian Passenger Lists to Be Indexed

Ancestry.ca will be collaborating with Library and Archives Canada (LAC) to produce a comprehensive nominal index to Canadian passenger records covering the period from 1865-1935.

Digitized copies of all of the records are already available on the Library and Archives Canada website but cannot be searched by name. The new partnership between LAC and **Ancestry.ca** will initially focus on indexing Quebec City passenger lists from 1870-1890, which comprise more than 750,000 names.

LAC and **Ancestry.ca** will then continue to build a nominal index to the entire Canadian passenger list collection, including the ports of Halifax, St. John's, Vancouver, Victoria, and North Sydney.

Ancestry.ca and LAC also plan to provide electronic access to border crossing records from the U.S. to Canada (1908-1935) and other Canadian immigration records.

Scottish Census Records on Ancestry Library Edition

Transcriptions and indexes to all Scottish census records, 1841-1891, are now available in **Ancestry**.



United Church Archives Find a New Home

The United Church Archives (Toronto) will move to a new location in 2008. The Archives are part of a network of regional archives in 10 locations across Canada. Holdings of the Toronto branch include records of United Church conferences in southern Ontario as well as previous records of the churches that amalgamated to create the United Church of Canada in 1925 (mainly Methodist and Presbyterian).

After many years at the Victoria University campus of the University of Toronto, the new home of the United Church Archives will be at the United Church of Canada's General Council Office, 3250 Bloor Street West in the west-end of Toronto. The new location is close to major transportation routes, including the Islington subway station, and will offer on-site parking.

Because of the move, the collection will be temporarily unavailable after December 21, 2007. The reading room is due to open at its new location on May 5, 2008. For more information, check the United Church Archives (Toronto) website at www.united-church.ca/archives.

New "Hidden" Birth, Marriage and Death Records for England and Wales Now Online

A new source of birth, marriage and death information for England and Wales is now online as the result of a collaboration between the National Archives (U.K.) and S&N Genealogy Supplies, a genealogy digitization company.

The Official Non-Parochial BMDs Service (www.bmdregisters.co.uk) offers access to information from unpublished registries covering the period from 1564-1865, and is especially useful for locating records of births, marriages and deaths prior to the start of civil registration in 1837. The scope of the website includes records of millions of Nonconformists - individuals who belonged to religious denominations that did not conform to the established Church of England (Anglican).

The first phase of the **Official Non-Parochial BDMs Service** includes the following records:

- Royal Hospital Chelsea (1682 onwards)
- Royal Hospital Greenwich (1694 onwards)
- Dr. Williams Library (1742-1865)

- Presbyterian, Independent and Baptist Registry (1742-1837)
- Wesleyan Methodist Metropolitan Registry (1818-1838)
- Bunhill Fields Burial Ground, Hackney (1712 onwards)
 South London Burial Ground, Walworth (1819-1837)
- Necropolis Burial Ground, Everton, Liverpool (c1825-1837)



Also included in the initial launch are 200,000 birth certificates from the Protestant Dissenters Registry and 50,000 birth certificates of Metropolitan Wesleyan Methodists.

Future plans include the addition of many more hidden records from a variety of sources, including records of British births, marriages and deaths abroad, registers of births, deaths and marriages at sea and others.

Basic searching is free, but users must register to use the **Advanced** search feature and buy credits to view full record details and digitized images.



AncestorsOnBoard.com (see *Genealogical Resources Newsletter - Issue #19, Spring 2007*) has added a further two decades of passenger lists to its database. Coverage now extends from 1890-1939. Eventually the database will include more than 30 million names up to 1960. The newest release includes more information than found in previous decades, including the last address of each passenger in the U.K.

DoVE... Delayed!

A British government scheme to provide online access to all post-1837 birth, marriage and death records has suffered a massive setback. The expensive **Digitisation of Vital Events** (**DoVE**) scheme was intended to put 250 million records online by May 2008. Completion is now not expected until mid-to-late 2009.

Meanwhile, the Family Records Centre in London, which provided access to original paper indexes, is slated to close at the end of March. The closure was planned in anticipation of the online search facility becoming available in March 2008. With the delay, the indexes have been transferred and can now be consulted at the National Archives at Kew.

Genealogists planning trips to London should take note, but delays in the DoVE scheme are not likely to affect genealogists doing remote research. Visitors to the Vancouver Public Library can still search the indexes using **Ancestry Library Edition** or consult the searchable online version of the indexes, **FreeBMD** (www.freebmd.org.uk/). As in the past, it continues to be necessary to order (and pay for) copies of the original records.

When DoVE is complete, it will be possible to view British vital event records online.



Irish Times Online Archive



The Irish Times recently announced a full online archive of the newspaper. Two formats are available: **Digital** (comprising digital scans of newspapers from 1859 to present) and **Text** (covering the period from 1996 to present).

Keyword searching of the **Digital Archive** is free and results show a small portion of the scanned text. A subscription is required to access full digitized articles,.

News from Scotland's People

Corrected Entries Now Online

Scotland's People (www.scotlandspeople.gov.uk) recently announced that RCE images can now be viewed online.

RCE stands for Register of Corrected Entries or (since 1965) Register of Corrections.

Once a birth, marriage or death was registered and entered in a Statutory Register, it would not be corrected if an error was found or new information became available. Instead, a separate new entry would be made and entered in a separate register, after being approved by a sheriff. A cross-reference to the amended entry would then be added to the original entry in the Statutory Register.

If there is an amended entry, it can now be viewed online. If such an entry is available, a "View RCE" button will direct the researcher from the original to the amended entry.

New Census Search Feature

It is now possible to search census records using two forenames that you expect or hope to find in one household. This should greatly reduce the number of hits when searching for historic census records. For example, if you want to search for a household in which you know the names of both the husband and wife, you can now enter both forenames.

As a caveat, users should be aware that the search function is based on names appearing on a single census page. Thus, a search may match entries from different households if both forenames appear on the same page, even though they are in different households. Also, the search will not return results from households spread over two pages in which each of the members appears on a different page.

<u>Search for Unrecorded Mother's Maiden</u> <u>Surname in Statutory Death Registers</u>

When searching **Scottish Statutory Death registers**, it is now possible to search for the mother's maiden surname. These surnames were recorded on the original Death registers but were not entered in the original indexes that were derived from the registers (and later digitized). The GROS is in the process of entering the surnames in the modern electronic indexes. It is now possible to search by mother's maiden surname, although it will not be found if it has not yet been entered into the indexes.

A free online digital library of local and trade directories for England and Wales covering the period from 1750-1919 is available. **Historical Directories**, a project of the University of Leicester, provides high-quality digital reproductions of the directories. The library can be searched by location, decade, or keyword.

A new website from the British Library, **India** Office Records: Family History Sources, provides guidance to genealogists researching British families in South Asia and related areas from the early 17th to the mid-20th centuries.

Resources include an India Office Family History Database (http://indiafamily.bl.uk/UI/) with access to about 300,000 records of British and European people in India between 1600 and 1949. The database is free and provides detailed transcriptions of information in each record. Copies of original records can be ordered online.

Online Graveyard Tours

www.ukgraves.info/

Photo albums of over 200 cemeteries in England and Scotland are available online. The albums mainly represent Berkshire, Hampshire, Wiltshire, Oxfordshire, Gloucestershire, and West Sussex, with some from other parts of England as well as Scotland. While there are few photographs of individual graves, the albums give a wonderful sense of the final resting places of many British ancestors.

British Military Genealogy

Information on British ancestors who died during World War I and World War II is available in 4 databases derived from casualty lists and rolls of honour. The database provides more details than provided in the online records of the **Commonwealth War Graves Commission**. Searching is free but there is a charge to view full record details and images from the rolls of honour.

OPC Scheme – Kudos to Dorset

The **Online Parish Clerks** scheme (OPC) is a collection of county-based projects with the aim of extracting and transcribing information from the records of various parishes and making them freely available online.

OPC projects currently exist for Cornwall, Cumberland & Westmorland, Dorset, Hampshire, Lancashire, Somerset, Sussex, Warwickshire, and Wiltshire. Dorset recently reached an impressive milestone, with more than one million records transcribed corresponding to approximately 275 Dorset parishes.

Archives Hub

A searchable online directory of collections held at university and college (and some other) archives in the U.K. is available through the **Archives Hub**. The directory provides information about an extensive range of resources of possible interest to genealogists and local historians.

Materials held by university and college archival repositories may include collections of personal papers, details of associations or

unions to which an ancestor belonged, or items relating to a location in which he lived. Examples of specific items to be found include diaries, membership lists, staff records, diaries and other information. For example, a search for William Parsons in Nottingham identified a collection of "Diaries and letters of William Parsons, solicitor of Nottingham, and his son Frederick, solicitor of Nottingham and farmer of Coachford, Ireland, 1830-1886" in the Department of Manuscripts and Special Collections at the University of Nottingham. In some cases, item-by-item listings of the full contents of specific collections are provided.

The **Archives Hub** can be browsed or searched by keyword. Search results provide full contact and access information to the archives'. Materials must be consulted on-site.



British Historical Population Reports

www.histpop.org/

Detailed background information on the history of civil registration and census-taking in England and Wales is available in **Histpop** – **The Online Historical Population Reports Website**. About 200,000 pages of census and registration material as well as many ancillary documents are available on the website.

Histpop site does not include genealogical data, except for some examples from enumerator's books and other documents. The site is useful, though, in providing insights and background to the procedures used to collect the results, which may help decode information found in the records. Documents found in Histpop include detailed instructions to enumerators, examples of returns distributed to householders, maps of registration districts and other information. The project is hosted by the UK Data Archive at the University of

Essex and is funded by Joint Information Systems Committee as an Arts and Humanities Data Service – History project.



Air Ministry Combat Reports (1939-1945)

This new set of online documents from the National Archives is important viewing for genealogists with ancestors who were British pilots or navigators during World War II and took part in air fights.

The combat reports were completed by pilots immediately after landing and record important details of each mission. Reports include technical information about the types of aircraft involved, time, place, height and number of aircraft, range at which attack was carried out and likely casualties. Pilots also added personal narratives of events.

The index can be searched for free but there is a charge to view digitized original records.

The Long Long Trail

Hailed as one of the best World War I resources on the web, **The Long Long Trail** is the work of a British amateur enthusiast who lost a grandfather in the war. In addition to a large amount of information about the army, as well as specific battles, and battlefields, the site offers a **Researching British Soldiers** feature with specific tips for locating information on soldiers who survived as well as those who died. A detailed **Soldier's Life** section offers insight into the experiences of soldiers from enlistment to demobilization.

Small and Special

Family historians with London ancestors may be interested in exploring **Small and Special**, a website associated with the Hospital for Sick Children at Great Ormond Street.

The main feature of the site is **The Great Ormond Street Historical Patient Database**, a free resource derived from hospital's **Admission Registers** for the period from 1852-1914, which survived intact. Users can search for children by name, age, sex, and address. Future plans include the addition of the surviving **Registers for Cromwell House**, which was the Hospital's convalescent home at Highgate, from 1869-1910.

The website also includes information about doctors and nurses at the hospital and a photo gallery.



City of London Burials

An index to City of London Burials, 1742-1904 is now available on the findmypast.com/ website. The database contains details of burials in all but one of 98 churches within the City of London (the "square mile"). The one excluded church is the Chapel of St. Peter ad Vincula in the Tower of London. The database also includes burials from burial grounds and the ring of parishes on the fringes of the City of London. It currently contains about 350,000 entries. Searching is free but a subscription is required to view full details.

U.S. Genealogy Alert

An agreement recently announced between the U.S. National Archives and Records Administration (NARA) and FamilySearch sets the stage for the digitization of millions of U.S. historical documents over time. The bulk of the digitized images and their related indexes will be available for free on

FamilySearch will be operating specialized digital cameras 5 days at week at the National Archives in Washington D.C. and intends to expand to regional NARA facilities at a later date. The pilot project, currently underway, focuses on 3150 Civil War widow pension application files (approximately 500,000 pages).

Standard Finder

Names, dates and places are often recorded in non-standard ways in different kinds of records over time. **Standard Finder** allows users to search for a standardized name, date or place based on individual input.



Pedigree Viewer

This feature allows users to upload their own information and to generate and navigate complete pedigrees, up to 12 generations.

Research Wiki

The FamilySearch Research Wiki allows users to contribute to a large compendium of research information. Content can be viewed or contributed in 8 languages, and the site includes an "Ask an Expert" feature as well as online discussion groups.

Life Browser

The Life Browser allows users to organize, view and share genealogical information, pictures, records and stories about ancestors. Input is presented in visually rich **Life Pages**, including timelines, photographs, and more.

FamilySearch Indexing

Users volunteer to extract family history information from digital images of historical documents to contribute to the creation of searchable indexes that will be available to anyone for free. Current projects include the 1871 Canadian census.

The News Box



Buried within the **FamilySearch Labs** (see previous item) is a source of genealogy news worth checking on a regular basis. The News Box is part of the **Research Wiki** and can be accessed directly at

PaperofRecord.com -Free Online Access to Historical Newspapers

PaperofRecord.com provides access to a large and growing searchable archive of historical newspapers. After registering for free, users can search newspapers from many countries: U.K., U.S., Australia, Bahamas, Belgium, Chile, Ecuador, France, Germany, Ireland, Italy, Netherlands, Spain, Mexico, and of course, Canada. The online collection includes newspapers from B.C., Alberta, Manitoba, New Brunswick, Nova Scotia, Newfoundland, Ontario, Quebec, Prince Edward Island, Saskatchewan and Yukon. Holdings of individual newspapers vary greatly. For example, there are over 77,000 pages from the Perth Courier (Ontario), 1834 to 1987, but only 583 pages from the *Palladium* (Charlottetown, P.E.I.), 1843-1845.

Individual newspapers can be searched by keyword or browsed by date. Results are linked to digitized images of the newspapers.

Reconnecting Families Separated by the Shoah

A non-commercial online tool has been developed to facilitate contact between members of families separated by the Shoah (Holocaust) and their descendents.

The site is derived from two million pages of Shoah survivors' testimony collected by Yad Vashem, the Holocaust Martyrs' and Heroes' Remembrance Authority

(www.yadvashem.org/) in its Central Database of Shoah Victims' Names. Using a link on the ShoahConnect web page, users can install/upgrade the Google Toolbar (if necessary) and add a special

ShoahConnect button. The button allows users to associate their e-mail address with specific **Pages of Testimony** and facilitates contact between people associated with the same pages, with some privacy protection.
