

Hidden Gems

The McCabe List: Early Irish in the Ottawa Valley

Based on an important genealogical document discovered by Belfast genealogist John McCabe, The McCabe List is an outstanding resource for those with Irish ancestry in eastern Ontario and western Quebec. The original list was a petition drawn up by Irishmen working on the first section of the Rideau Canal near Bytown (Ottawa) in 1829. Names were gathered in response to inquiries by a British parliamentary committee exploring whether or not poor families in Ireland might be drawn to Canada if they were offered advances on passage money, land and provisions. The petitioners indicated that they approved the government plan and would be willing to reimburse the cost of having their near relations join them. Each of the almost 700 records includes the signature or mark of the petitioner, their county, parish, and town, village or townland of origin in Ireland, the size of their family, and detailed information on the names and residences of their Irish relatives.

1891 Canadian Census Records Online

In February 2009, the Canadian Genealogy Centre launched its new **Census of Canada**, **1891** database. The historical census records are searchable by name and other parameters. Results include PDF and JPEG links to digital images of the original census schedules. The site also provides extensive explanatory information about the 1891 census and detailed <u>Search Help</u>. As the first comprehensive database of 1891 Canadian census records available anywhere, the launch of this new resource is a significant event for genealogists tracing Canadian roots.

"Suggest a Correction" Feature Introduced

Canadian Genealogy Centre databases now include **Suggest a Correction** so that genealogists can submit recommended changes and other revisions. This feature is very useful, given the margin of error typical of historical genealogical records. As experienced genealogists know, mistakes occur at many stages, from the time that the records are actually created until they are transcribed and entered into modern computer databases.

When using Canadian Genealogy Centre databases and studying specific results – for example, the census entry relating to a particular individual – look for the **Suggest a Correction** link at the bottom. Click on it if there is an inaccuracy or discrepancy that you would like to draw to the attention of Library and Archives Canada staff. Clicking on the link generates a form that includes the actual record to which you are referring. This feature makes it very easy to suggest corrections and contribute to improving the accuracy of these important resources.

Ancestry Announces Global Project to Preserve Deteriorating Historical Canadian Records

Ancestry has launched the Canadian arm of the World Archives Project. As reported in the previous issue of this newsletter, Ancestry and the Federation of Genealogical Societies have jointly initiated a project aimed at creating indexes to genealogical information through the participation of volunteer contributors (for more information see

www.ancestry.com/worldarchivesproject)

The first Canadian records to be digitized and indexed as part of this project will be **Ontario**, **Canada Marriage Registers by Clergy 1896-1948**. The records include about 24,000 names from registrations compiled under the Registration Act of 1896.

Irish Canadian Emigration Records, 1823-1849

One week before St. Patrick's Day, Ancestry launched a series of online records based on a book entitled <u>Irish Emigration to New England Through the Port of Saint John, New Brunswick, 1841-1849</u> by Daniel F. Johnson. The database comprises 7000 names, fully indexed with original images. The names were found in the papers of two Canadian emigration agents, James Allison and A.J. Buchanan. The records include lists of emigrants, orphan records and other documents. Results are linked to digital images of original documents.

Poor Law Records Database Launched

Ancestry recently launched an important new database of London records. London, England, Poor Law Records, 1840-1938 comprises many types of records including admission and discharge books of workhouses, registers of individuals in the infirmary, creed registers, school registers, registers of children boarded out or sent to various other institutions, registers of apprentices, registers of lunatics, registers of servants, registers of children, registers of relief to wives and children, registers of inmates, registers of indoor poor, and registers

of deserted children. The records cover the London boroughs of Camden, Islington, Lambeth, Southwark, Tower Hamlets, Wandsworth and Westminster. Records are searchable by Borough, Poor Law Union and Keyword. Results are linked to images of original records.

Ancestry secured exclusive rights to digitize and host these and other key records from the London Metropolitan Archives and Guildhall Library Manuscripts collections in 2008.

<u>Searchable Indexes to U.K. Birth Records Now</u> Available

A collaborative effort between Ancestry and FreeBMD has resulted in the availability of online access to 134 million entries in the birth indexes of the General Register Office (GRO) in London. Although digital versions of the indexes had been available for some time, searches only retrieved lists of all the pages on which a searched name might appear, requiring a great deal of cumbersome browsing.

The birth indexes are available in two searchable Ancestry databases, and span almost 180 years of British civil registration records, from 1837-2005.

- England & Wales, FreeBMD Birth Index, 1837-1915
- England & Wales, Birth Index: 1916-2005

Using the new databases, it is possible to search for individuals by name and follow links to digital images of specific pages from the original indexes. The reference associated with each entry can be used to order the corresponding full registration record (online, by telephone or by mail) from the General Register Office, London, U.K.

Similar nominal indexes to marriage and death records are also planned.



British Directories

Ancestry has launched two extensive collections of information from historical British directories:

British Phone Books, 1880-1984

This database comprises 1800 telephone directories from the British Telecom Archives. The directories date from 1880, the year after the public telephone service was introduced in the United Kingdom, to 1984. Almost every county in England is represented and there are also many Scottish, Irish and Welsh directories. Earliest places represented are for Dublin and London. The directories are fully searchable with links to digital images of original directory pages.

U.K., City and County Directories, 1600s-1900s
This database contains almost 8 million entries from British trade directories. The directories provide information on British tradespeople, gentry, clergy, and "persons of note."
Tradespeople encompasses a wide range of individuals, from famous entrepreneurs such as Henry Harrod to chimney sweeps and "leech importers." The earliest directory in the collection is The London Directory of 1677 but by 1820, directories were being printed for every county.

U.K. Doctors' Records Online

In celebration of the 150th Anniversary of the General Medical Council (U.K.), the records of 1.5 million registered medical professionals have been made available on Ancestry. **UK Medical Registers, 1859-1959** includes details of all British doctors who were approved after compulsory registration was introduced to curb quackery.

The online registers can be searched by First Name, Last Name, Publication Year and Keyword. Digital images of the registers include the Date of Registration, Name, Residence, and Qualifications of each individual.

Late 20th-Century U.S. Records Available

Names, addresses, ages and possible family relationships of people who lived in the U.S. between approximately 1950-1990 can now be searched in Ancestry's **U.S. Public Records Index**. The database of almost 535 million names and addresses was built from a variety of city directories and other public records.

U.S. Civil War Databases

In February, Ancestry commemorated the 200th birthday of U.S. President Abraham Lincoln by adding 5 new databases to its Civil War collection. The new databases include:

- Abraham Lincoln Papers (approx. 20,000 names)
- Confederate Applications for Presidential Pardons, 1865-1867 (approximately 15,000 names)
- Georgia, Confederate Pension Applications, 1879-1960 (approximately 63,000 names)
- New Orleans, Louisiana, Slave Manifests, 1807-1860 (almost 598,000 names)
- U.S. Civil War Soldier Records and Profiles (approximately 4.2 million names)



New Jewish Records Online

Millions of Jewish records, including immigration and Holocaust records, are now available through new partnerships between Ancestry and two leading Jewish heritage organizations:

Databases provided in partnership with the Jewish Joint Distribution Committee:

Canadian Census Indexes Project

In collaboration with Ancestry and with help from volunteers, FamilySearch has launched indexing projects focusing on 1861, 1871 and 1916 Canadian census records. In the case of 1861 and 1871, these projects will provide the only comprehensive access to these records yet available. The indexes will be available for free at www.familysearch.org

New Collections Added to Record Search

FamilySearch continues to add new indexes and images to its outstanding free **Record Search** site.

An exceptional new resource is the **Ireland Civil Registration Indexes**, **1845-1958**. This new database covers all of Ireland and includes indexes to Protestant marriages (1845-1958) and to birth, marriage and death indexes for all denominations from 1864-1958 (1959 for Northern Ireland).

All-Obituary Cable Channel Planned

Quebec entrepreneur Gerald Dominique has announced plans to launch "Je me souviens," a channel dedicated to broadcasting digital obituaries. The channel will charge a fee to broadcast obituaries, prayers, hospitalization notices and messages of thanks. Dominique has obtained a license from the CRTC and plans to expand the channel to the rest of the country as "Remember the Name." The obituary channel will begin broadcasting by summer 2009. A similar channel, Etos TV, was launched in Germany in 2008 with considerable fanfare.



Canadian Mayflower Descendants

In 2010, the Canadian Society of Mayflower Descendants will celebrate its 30th anniversary. Judy Swan, the Governor General of the General Society of Mayflower Descendants (U.S.), will visit Canada to help celebrate the event.

The Society, which is based in Toronto with colonies in B.C., Alberta, and Nova Scotia runs various activities and maintains a New England research collection at the North York Public Library. It also publishes a newsletter, Canadian Pilgrim.

1911 U.K. Census Update

As reported in the previous issue of this newsletter, public release of 1911 U.K. census records began in early 2009, three years ahead of the originally scheduled release date of January 2012.

At launch, about 80 percent of the records were available. In early April, it was announced that all English counties are now complete. Scanning of Welsh records has commenced and some Welsh data is expected to be available within the next 4-6 weeks.

British Fee-Based Sites -Highlights

Marriage Registers of St. Andrew Holborn, London

The subscription website British Origins now includes indexes to 92,000 names from the marriage registers of St. Andrew Holborn, London, covering the years from 1754-1812. St. Andrew Holborn was one of the largest parishes in London and was subsequently split into five smaller parishes. The records are invaluable for genealogists with ancestors in central London. Some are not available in other key sources, such as the International Genealogical Index and Boyd's Marriage Index.

Get-A-Map (U.K. Ordnance Survey)

Free online access to small-scale maps of the U.K. is available from the venerable Ordnance Survey. Entering a place name generates a small map pinpointing the location. Users can then zoom-out to see the location in its broader geographical context.

PRONI Introduces Online Catalogue

The Public Record Office of Northern Ireland has introduced an online catalogue of the over 1 million items held in its archives. The records can be searched by keyword, accession number and date and in many cases include full transcriptions. The PRONI eCatalogue is available at:

African-American Collection Launched on Footnote.com

In January, Footnote.com launched a new African-American collection to celebrate Black History Month. More than one million original documents, letters and photos, most digitized for the first time, are now available online in collaboration with the National Archives (U.S.)

 Service Records for Colored Troops in the Civil War – Records for the 2nd-13th infantries including enlistment papers, casualty sheets, oaths of allegiance, proof of ownership and bills of sale.

- American Colonization Society Letters and reports relating to this colony established in 1817 for free people of color residing in the U.S.
- Amistad Case Handwritten records of this landmark case beginning in 1839 involving the Spanish schooner Amistad, used to transport illegal slaves.
- Southern Claims Commission Petitions for compensation resulting from the Civil War.

Searching the indexes is free but there is a charge for viewing records.

Additional record collections will be made available in coming months.

Roots Television Now Full Screen

Roots Television is a free Internet-based television channel offering a wide variety of interesting videos on genealogy-related topics. Until recently, the films could only be viewed in a small screen window, but a significant improvement has now made the films available on the full screen.

To view genealogy videos, go the Roots Television site and look for the Browse Videos box with the drop-down arrow at top-right. Click on any item in the menu to display a list of films related to that topic.

Select a film and click on the link to begin play. When the small screen launches, look for square icon with arrows pointing out in four directions. Click on the icon to blow the video up to full-screen.

An interesting tool that can be used to determine the modern equivalent in U.S. dollars of what your ancestor was paid or paid for various goods and services.

Enter your own and your relative's relationship to a common ancestor (for example, you are the great-grandchild and your relative is the grandchild). The calculator will determine your relationship to your relative (e.g. first cousins, twice-removed).

Mass Observation: Recording Everyday Life in Britain

The Mass Observation Project (MO) was a British initiative started in 1937 for the purpose of documenting the lives and thoughts of the general public. Methods used to collect information included employing professional observers who were paid to write what they observed and overheard at public facilities. Another approach was the periodic sending out of questionnaires ("directives") asking specific questions spanning a wide range of topics. During the Second World War, a special "Crisis Directive" collected information on wartime subjects and asked people to begin keeping diaries.

The MO project continued into the 1950s and was revived in 1981 with new volunteers. Participants are still sent directives about three times a year asking for information on a variety of themes.



The Mass Observation Archives is housed at the University of Sussex and is open to the public for historical research. While the Archive has not been digitized, its holdings are searchable online. Names of diarists and other individuals are suppressed but documents associated with specific locations and years can be identified. Some remote services are available.

Many publications based on the Project's findings have been produced and provide insight into daily life in Britain.

Kiwi Records Online

In late February, New Zealand's Ministry of Internal Affairs launched a website providing online access to historical New Zealand birth, marriage and death records.

The site indexes the following New Zealand vital event records:

- Births that occurred at least 100 years ago
- Stillbirths that occurred at least 50 years ago
- Marriages that occurred at least 80 years ago
- Deaths that occurred at least 50 years ago
 OR the deceased's date of birth was at least
 80 years ago.

Copies of original registrations may be ordered online for NZD \$20 (approximately CAD \$13) in the case of post-1875 documents, or NZD \$26 (CAD \$17) for pre-1875 records.
